- Quarterly distribution of \$0.6075 per unit attributable to the third quarter of 2016
- Distribution is 5.2% increase in distributions per unit over third quarter of 2015

**ALLENTOWN, PA (October 24, 2016)** – CrossAmerica Partners LP (NYSE: CAPL) announced today that the Board of Directors of its general partner has approved a quarterly distribution of \$0.6075 per unit attributable to the third quarter of 2016 (annualized \$2.43 per unit), representing a 0.8% increase in the Partnership's cash distribution per unit from \$0.6025 per quarter (\$2.41 per unit annualized) paid with respect to the second quarter of 2016 and a 5.2% increase compared with the distribution per unit attributable to the third quarter of 2015. The distribution attributable to the third quarter is payable on November 15, 2016 to all unitholders of record on November 4, 2016.

CrossAmerica will host a conference call on November 8, 2016 at 9:00 a.m. Eastern Time (8:00 a.m. Central Time) to discuss third quarter 2016 earnings results, which will be released after the market closes on Monday, November 7.
